County Recognition of Quaker Springs Fire District: Supervisor Ian Murray stated representatives from Saratoga County Government were present to recognize the Quaker Springs Fire District.

Steve Bulger, County Administrator, Director of Emergency Management, Mike Stanley, County Director of Fire Services and Andre Delvaux, Saratoga County Office of Emergency Management, were present for this recognition. Steve Bulger stated Quaker Springs Fire District played a very important role in helping the Towns of Edinburg and Day, when in July, 2024, a tornado touched down causing devastating damage. In the narrow area that was hit, there was a tremendous amount of damage to the point where people were trapped and there was no way of knowing the level of physical harm or injuries to them, as all roads were blocked by many downed trees. Emergency services could not drive in due to that and there was no way of getting through to them as there were no radios, cell service was down and they were receiving reports it was a very serious situation. Sheriff Zurlo was the over-all coordinator and working with Andre and Mike, they brought in dozens of first responders from across the county and other counties, to help get in to those areas that were cut-off. As the hours went on, they knew people could really be in need help. QSFD played a really important role, more so and different than almost any other responders there, which is why they were present to recognize and honor them. Mike Stanley, Saratoga County Fire Coordinator, stated he wanted to take a moment to highlight the sacrifice and their appreciation for the Quaker Springs Firefighters. For those who don't know, QSFD has a unique boat with a fire pump on it, serving the Saratoga Lake region, it's residents and visitors to the lake. The morning after the tornado struck, they received a call from a deputy coordinator that QSFD had a boat with a pump on it and there was a large inaccessible area to vehicles and fire trucks due to tornado damage and downed trees and asked if they could get that resource up there to support the operation. QSFD brought the boat up and the next day there was a structure fire that was in one of the inaccessible areas on the side of the lake. The Quaker Springs Firefighters were able to use the boat, provide water (pumping it out of the lake) to stop the spread of the fire and preserve life and property. That was a very unique use and Saratoga County is very fortunate we have a fire community that works so well together, which is rarely brought up. They wanted to thank them for their time, equipment and for supporting the effort.

Steve Bulger then asked the Quaker Springs Firefighters to join him and presented them with the following certificate: "Saratoga County Board of Supervisors' Certificate of Appreciation in recognition of the selfless efforts and unwavering dedication of the great men and women who answered the County's call for assistance in response to the July, 2024 tornado in the Town of Day and Edinberg. We thank you for your heroic service and unyielding commitment to ensuring the safety of our residents and the swift return to normalcy to the affected communities."
