Supervisor Thomas Wood opened the meeting at 6:00 p.m. with the Pledge of Allegiance.

Roll call: Town Clerk, Linda McCabe, called the roll: Supervisor Thomas Wood- present, Councilman Michael McLoughlin – present, Councilwoman Ruth Drumm – present, Councilman Gary Squires – present, Councilwoman Maxine Lautenburg – present.

Recognitions/Presentations/ Bid openings/Public Hearings: Supervisor Thomas Wood stated we have a public hearing this evening, to adopt the 2023 Budget, but first he had a special resolution he wanted to present. He recently learned that our Congresswoman would be in Town this evening and also the fact that several district lines have been changed and unfortunately, after December 31, our Congresswoman will no longer be our Congresswoman. We have been honored and privileged to have had her represent us in Congress and hope she continues to be a resident of our Town. He then stated, on behalf of the Town Board he prepared a resolution and asked Congresswoman Elise Stefanik to please come forward. After congratulating her on her re-election he presented her with the following resolution:

Resolution #22-87 – Honoring Congresswoman Elise Stefanik

WHEREAS, Congresswoman Elise Stefanik is a resident of the Town of Saratoga; and *WHEREAS*, Congresswoman Elise Stefanik has proudly represented the 21st Congressional District, serving the Town of Saratoga for four terms; and

WHEREAS, Congresswoman Elise Stefanik is the highest ranking public official and only Congresswoman to have ever lived in the Town of Saratoga; and

WHEREAS, Congresswoman Elise Stefanik has always supported the residents of the Town of Saratoga and given generously of her time and talents; and

WHEREAS, Congresswoman Elise Stefanik has always recognized and supported the rich historical history of the Town of Saratoga and the role that this history has played in the American Victories in the Battles of Saratoga, the surrender of an entire British Army under the command of General Burgoyne and the joining in of France, referred to as America's Turning Point, in support of the American effort to form a new independent nation; and

WHEREAS, before becoming a Congresswoman, Elise Stefanik served in the West Wing of the White House on President George W. Bush's Domestic Policy Council in the Office of Chief of Staff overseeing the development of economic and domestic policy issues; and

WHEREAS, prior to serving in Congress, Congresswoman Elise Stefanik graduated with Honors from Harvard University and worked in her family's small business, teaching her the hard work and perseverance necessary to build, operate and grow a small business; and

WHEREAS, Congresswoman Elise Stefanik is a member of the House Armed Services Committee, the Committee on Education and Labor and the House Permanent Select Committee on Intelligence; and

WHEREAS, Congresswoman Elise Stefanik is on the Sub-Committee on Cyber, Innovative Technologies and Information Systems, the Sub-Committee on Strategic Forces, the Sub-Committee on Higher Education and Workforce Investment and the Sub-Committee on Workforce Protections; and

WHEREAS, Congresswoman Elise Stefanik's Congressional District boundaries have been changed, resulting in the Town of Saratoga no longer being in her District; now, therefore, be it

RESOLVED, that we, the Town Board of the Town of Saratoga, express our sincere thanks and appreciation to Congresswoman Elise Stefanik for her service and devoted dedication as a public officer; and be it further

RESOLVED, that these expressions of gratitude be made a permanent record of the minutes of this meeting.

On a motion by Supervisor Thomas Wood and seconded by Councilmember Michael McLoughlin, the previously read **Resolution #22-87 – Honoring Congresswoman Elise Stefanik,** was adopted by vote: Supervisor Thomas Wood - aye, Councilman Michael McLoughlin – aye, Councilwoman Ruth Drumm – aye, Councilman Gary Squires - aye, Councilwoman Maxine Lautenberg – aye.

Congresswoman Elise Stefanik thanked Supervisor Thomas Wood sincerely for the honor of the resolution and said they love living in the Town of Saratoga and she and her husband can't think of a better place to raise their son. She said she's so sad to lose so many of her constituents in Saratoga County with the redistricting; it's been a humbling experience and an honor representing all of you. They are only two cornfields less than a mile outside the district line, so she's very familiar with the district, which the rest of it stayed pretty much the same. She then stated she wanted to honor a tremendous local leader and present as one of her last congressional records in her current NYS 21st Congressional to honor Saratoga Town Supervisor Tom Wood. She then stated the following is part of the Congressional Record, proceedings and debates of the 117th Congress, Second Session:

"House of Representatives Honoring Saratoga Town Supervisor Thomas N. Wood III

Ms. Stefanik of New York: Madam Speaker, I rise today to honor lifelong Saratoga resident and Town Supervisor, Thomas 'Tom' Wood. Tom has dedicated his life to making Saratoga an exceptional community, and I am proud to thank him for his service.

Tom was raised in Saratoga and attended Schuylerville Central School. He went on to attend Cornell University where he graduated with a Bachelor of Science in Agriculture and Education in 1967. After graduating from Cornell, he dedicated his teaching career to educating the next generation of agricultural leaders. He first taught at Saratoga BOCES and then went on to teach Agriculture and Technology courses at SUNY Delhi and Salem Central School. In 1993, Tom became the Assistant Principal of Salem Central High School and then worked as the Elementary School Principal from 1996 – 2002.

In addition to teaching, Tom found many ways to mentor the next generation. He led the Schuylerville Boy Scouts and coached various Little League teams. Tom was incredibly devoted to serving and bettering his community. He was Chairman of the Zoning Board of Appeals for the Town of Saratoga for over two decades. He also worked hard to preserve and promote the important history of Saratoga as the historian for the Town of Saratoga, the Villages of Victory and Schuylerville.

In 2004, Tom became the Saratoga Town Supervisor and has served in this role ever since. In his role as Town Supervisor, Tom has prioritized open and honest communication between himself and the community to ensure the Saratoga Town government remains transparent and accountable. Thanks to Tom's strong leadership, Saratoga is a community with a deep

connection to its important historical significance and deep understanding of its agricultural roots.

Tom's commitment to bettering Saratoga for all who call it home is inspirational. On behalf of New York's 21st Congressional District, I am honored to recognize Tom's leadership and thank him for his decades of service to the Town of Saratoga."

Congresswoman Elise Stefanik then presented Supervisor Thomas Wood with an official copy of the Congressional Record and thanked Supervisor Thomas Wood again for all he's done for our community. Supervisor Thomas Wood thanked her sincerely.

Tim Holmes, President of the Friends of Saratoga Battlefields, then presented Supervisor Thomas Wood with the following:

"250th Anniversary Work Group, Battles of Saratoga 1777 – 2027:

The 250th Anniversary Work Group honors Thomas N. Wood III for his enduring belief in the spirit of Saratoga. It led to his many long-term contributions to the greater Saratoga community. Always passionate about cultural pursuits, Tom learned and taught others about the Saratoga battles and their meaning for patriotism.

He administered education as a fulltime career and instilled the lessons of history in the community. For any interest in which he has been involved, Tom is the epitome of the active volunteer, contributing significant hard work and leadership talent to make plans real, as illustrated by his interest in and contributions to the Town of Saratoga.

We celebrate Tom's generosity and community spirit!

All Tom's work serves the national memory and will continue to deliver impact, enduring for the ages to come."

Supervisor Thomas Wood thanked him sincerely.

Supervisor Thomas Wood asked those wishing to speak to please stand and state their name and address; no one came forward. On a motion by Supervisor Thomas Wood and seconded by Councilmember Michael McLoughlin, the public hearing was closed at 6:28 p.m.

Old Business: Supervisor Thomas Wood went through the draft response for the Corrective Action Plan to the comptroller's office. He asked the Board to read through it and get back to him with their thoughts and suggestions. All Board members must sign off on the plan prior to sending it in; deadline is December 2, 2022.

The Board discussed sound absorption panels and ways to mitigate acoustic issues in the Schuyler Room. Gil Albert has reached out to local companies that do this work and they came in, measured and gave a proposal for both walls and ceiling and noted they said ceiling is best, but a band of panels around the room could be done first and then, if needed, do the ceiling. He said the Board can choose the color and design of the panels as well. He then stated he's working on making the mural panels mobile for the room as well. The Board also discussed updates for the vestibule in the lobby and new doors. Gil Albert said he doesn't believe an airlock is cost effective for the lobby and doesn't think it would look good and you have to meet building codes. Councilmember Gary Squires agreed with him.

Councilwoman Maxine Lautenberg stated she would like the Board to register with the Climate Smart program to get the \$5,000 grants. Gil Albert stated they should look into that, as he didn't think you can get the grant on things that have been previously done.

Gil Albert and Ian Murray spoke on the proposed amendment to Zoning regulation 400-8.12. They said the draft is a fair and balanced amendment and they are working on the procedure and permitting part of it and suggested the Board review it. Ian Murray said he shared it with Dustin Lewis of Saratoga County Soil & Water Conservation District and Blue Neils of Cornell Cooperative Extension of Saratoga County Stormwater Management and they gave great feedback and will give comment on mitigating factors of it.
