Ouaker Springs Fire Department News

The upcoming annual election of a fire commissioner will take place at the fire house on December 8th from 6:00 pm to 9:00 pm at the Quaker Springs Fire House located at 107 Blodgett Rd, Quaker Springs, New York, 12871, for the purpose of electing one Commissioner for a five (5) year term, commencing January 1, 2010 and ending December 31, 2014. Voters must be 18 years of age or older, must be a resident of the Quaker Springs Fire District prior to November 8, 2009 and must be registered to vote with the Saratoga County Board of Elections prior to November 16, 2009 to be eligible to vote. Stanley Bialahoski has served the district for over 55 years and is not running for re-election as a commissioner. The two candidates running for office are Don Parker and Dave Poltynski.

The Assessor's Office has been busy preparing itself for the busy exemption season. We will be mailing renewal applications on December 10th for the 2010 Roll. Please watch for these important forms. They need to be filled out and returned to our office no later than March **1, 2010** in order to be included on the 2010 Assessment Roll. Our exemption forms are "color coded" to help identify the appropriate exemptions. The Senior Star renewal applications are blue, the low-income Senior Exemption renewal forms are pink and the Agricultural renewal forms are green. If you have questions or concerns about any exemption, please do not hesitate to contact our office at 695-3644, ext. 312 or ext. 321. Our office is located at 12 Spring Street on the 2nd floor and that is where you will need to submit your application. Applications may be submitted either by mail or in person.
