In the event of an emergency the primary shelter for the *Town of Saratoga* will be at the *new Town Hall Building* located at 12 Spring Street Schuylerville. The building is at the intersection of State Routes 4, 29, and 32. Enter the building through the doors adjacent the rear of the parking lot, and follow the signs to the shelter.

Secondary shelters will be used if the need arises. They will be located at the David Nevins Fire Station Pine Street, Victory Mills, the Quaker Springs Fire Station Blodgett Road, Quaker Springs and the Schuylerville Central School Spring Street, Schuylerville. The severity and duration of the event will determine when the shelters are opened, and for how long they remain in operation.

Town Tax Collector

Town Tax Collector James Gorham recently mailed tax notices for all parcels in the town. Residents may pay their taxes in person at the town hall or mail them to the tax collector. During January, Jim will collect taxes in his office at the Town Hall on Mondays, Wednesdays, and Fridays from 8:30 a.m. to 12:30 p.m. and from 1:30 pm to 4:00 pm. On Saturday, January 29th taxes may be paid from 8:30 a.m. to 12:00 noon. During February and March, Jim will be in his office on Monday's only from 8:30 a.m. to 12:30 p.m. and from 1:30 pm to 4:00 pm. Taxes may be mailed to Jim at anytime. Assessor News

Greetings From the Assessor's Office Happy New Year! Now is the time for all property owners to look over their information and start filing for any exemptions they may be qualified to receive. If you will be <u>65 in the year 2011</u>, you are eligible to apply for the Senior Star Exemption. But, you must file before March 1, 2011.

Many exemptions require renewal applications. These applications are color-coded and have been mailed. Please take time now to fill these out and turn them in to the Assessor's office. The deadline for renewal applications is March 1, 2011.

Home owners in the town who reside in their property are eligible for Residential Star. This is a one-time application. If you have not already filed to receive these savings to your school taxes, you need to apply before March 1, 2011.

Other exemptions available within the town include Veterans exemptions, disability exemptions, and Agricultural exemptions. Certain criteria must be met to qualify for these exemptions. Please contact our office to determine if you might be eligible. All exemptions must be filed by **March 1, 2011**.

Reminder: The Assessor's Office is open Monday – Thursday from 9:00 AM until 1:00 PM. Please stop in and visit us – we'll be happy to answer your questions and help you apply for any exemptions you may be entitled to receive.
