## **Turning Point Parade Activities**

This year the Turning Point Parade activities have been expanded. On Saturday August 4<sup>th</sup> there will be carnival events, a U.S. Water Skiing team demonstration, food vendors and music at Fort Hardy Park. The 14<sup>th</sup> annual Turning Point Parade will be held on Sunday, August 5<sup>th</sup>. The parade will start at 1:00 pm beginning at the school parking lot and traveling down Spring Street to Broad Street terminating at the Schuyler House. This promises to be the biggest and best parade so far! Please make an effort to attend and share a great time with your family and friends. Following the parade, a number of activities will continue at Fort Hardy Park. These include a chicken barbecue, carnival rides, food vendors, a number of musical performances, and a petting zoo. ### Assessor's News - Middle Class STAR

The enacted NY State budget for the fiscal year 2007 includes a real property tax relief program known as "Middle Class STAR". The new program expands upon the existing STAR program by providing an increased benefit for homeowners with "affiliated" incomes less then \$250,000. The increased benefit will be administered by the NYS Department of Taxation & Finance and will be paid in the form of rebate checks. The increase in the Basic STAR benefit will be determined on a sliding scale keyed to income affiliated with the property. Applications may be submitted online or via regular mail, and applicants will be notified of the need to apply by the NYS Department of Taxation & Finance. Applicants will not have to reapply for the rebates in future years. Those who receive the Enhanced STAR will receive a rebate check in an amount equal to 25% of their 2006-2007 savings this year. Recipients of the Enhanced STAR will receive their checks automatically and will not have to apply.

#### **Town Hall Building Committee Update**

On June 6th the Town Hall Building Committee met in the former corner school with Sonny Bonacio and Larry Novak to gather more details about the operation and costs related to the building. Members of the Town Hall Building Committee and the Town Board are busy doing research and gathering information related to the former school at the corner of Broad and Spring Street. The town Board has approved funds for an appraisal of the building that will be completed by the end of July. Residents are encouraged to share their opinions about a new town hall with town officials and members of the building committee.

## **Learn to Swim Program**

Registration for the Town of Saratoga "Learn to Swim Program" was conducted on June 25<sup>th</sup>. This year there will be two, four week sessions. The first session will run from July 2<sup>nd</sup> to July 27<sup>th</sup> and the second session will run from July 30<sup>th</sup> to August 24<sup>th</sup>.
