The next meeting of the Town Board is scheduled for Monday, May 11<sup>th</sup> at 7:00 p.m. Some of the items that will be covered at this meeting include: zoning officer's report, town clerk's report, supervisor's report, committee reports, a public hearing on the Sunday on the Farm Mass Gathering application, and a review of speed limit requests for county routes 338 and 68. On Thursday, May 7<sup>th</sup> the Town Board will conduct their monthly agenda meeting at which they will review agenda items scheduled for the May 11<sup>th</sup> meeting.
