The next meeting of the Town Board is scheduled for Monday, May 10<sup>th</sup> at 7:00 p.m. Some of the items that will be covered at this meeting include: zoning officer's report, town clerk's report, supervisor's report, committee reports, and Opening Bids for the sale of the shed at the old town hall. On Thursday, May 6<sup>th</sup> the Town Board will conduct their monthly agenda meeting at which they will review agenda items scheduled for the May 10<sup>th</sup> meeting.

Starting Friday, May 28<sup>th</sup> the Town Hall Summer Hours will begin. The town offices will close at 12:00 noon on Fridays.

## 2010 Census Update

It is important to future Federal and State aid to the Town and the two Villages that you return your completed census questionnaire. Some of you may not have received your Census Questionnaire. If you have a Post Office Box, as is the case for many of the residents of Victory and some of the Schuylerville residents, the Post Office returned your street address questionnaires to the Census Bureau as undeliverable.

The Census Bureau will send canvassers to every non-responding household (did not return completed questionnaire; this includes Post Office Box Holders) to attempt completion.
