# Warm Greetings to Everyone!

Once again the summer has flown by and it does not seem possible that September has arrived! September will be another busy month filled with town activities. The next meeting of the Town Board is scheduled for Monday, September 11<sup>th</sup> at 7:00 p.m. Some of the items that will be covered at this meeting include: zoning officer's report, town clerk's report, supervisor's report, town hall building committee report, adult entertainment law public hearing, and committee reports. The Town Hall Building Committee will meet on Wednesday. September 6<sup>th</sup> at 6:00 pm and the Town Board Agenda meeting will be held on Thursday, September 7<sup>th</sup> at 7:00 pm. The town offices will be closed Monday, September 4<sup>4h</sup> in observance of the Labor Day Holiday. Beginning Tuesday, September 5<sup>th</sup>, the Town offices will be open daily Monday thru Friday from 9:00 am to 4:00 pm.

The Building Committee continues to meet and review space needs and building location options. It is now apparent that we will not meet our original goal of presenting a building proposition to the voters at the November general election. We need additional time to review alternatives and schedule meetings with residents of the town to obtain their opinions and suggestions. A special vote will be scheduled in the future.

We have conducted our first budget workshop and are off to a great start. Our goal is for no increase in the current town tax rate.

There is currently an opening on the Board of Assessment Review. This board normally meets two times a year to review assessment concerns and make recommendations for changes as needed. If you are interested in serving on this board, please contact Tom Wood, Supervisor.

The town board has received requests for the installation of four-way stop signs at the intersections of Burgoyne Road and DeGarmo Road and Burgoyne Road and Hayes Road. Saratoga County Department of Public Works is looking into this request. In addition we have received concerns about the intersection of Louden Road and NYS Route 29. This has been referred to the NYS Department of Transportation for their review.

## **Town Youth Festival**

The Town of Saratoga and Town of Northumberland will jointly sponsor the 2<sup>nd</sup> annual Youth Festival at Fort Hardy Park on Saturday, September 16<sup>th</sup> from 5:00 pm to 8:00 pm. The day will be packed with activities including organized games such as tug of war, three legged races, a water bucket brigade contest, a sack race, an egg and spoon relay, interactive booth games, volleyball and kick ball. There will be arts and crafts, a bounce house, inflatable slide, pony rides, and a demonstration by Pai's Tae Kwon Do Studio. In addition, Toukie the clown and Maure Wade the ventriloquist will perform, the Sheriff's department will do free fingerprinting, the fire department will provide fire safety information, and there will be free food for all children. The program will end with a special fireworks display. This promises to be a fun filled event for all residents of the Town of Saratoga and Town of Northumberland and will be held rain or shine. Spread the word and encourage all children to participate.

### Name the Town Park

We are in the process of identifying a name for the new town park to be located on Route 29 across from the Farmer's Daughter. Residents are encouraged to submit suggestions to Tom Wood.

### **Revised Adult Entertainment Law**

The town board has prepared a new revised adult entertainment law for review by the public. The new law identifies the Rural Zone as the possible location for adult businesses. Separation distances between adult businesses and other uses have been increased to 1,000 feet and the lot size requirements have also been increased. A public Hearing will be conducted at the September 11<sup>th</sup> meeting. A copy of the proposed law is on the town web page.
