April 13, 2015 7:00 P.M.

Supervisor Thomas Wood opened the meeting with the Pledge of Allegiance at 7:00 p.m.

Roll call: Ruth Drumm, Town Clerk, called the roll. Supervisor Thomas Wood- present, Councilman Fred Drumm - present, Councilman Charles Hanehan- present, Councilman Michael McLoughlin – present, Councilman James Jennings - absent **Also present:** Deputy Town Clerk Linda McCabe, Town Attorney William Reynolds, Zoning Officer Gil Albert, Highway Superintendent Don Ormsby Jr., Sherry Doubleday, and Mike Marshall

Recognitions/Presentations/ Bid openings/ Public Hearings:

Public Hearing on the Mass Gathering Permits for Saratoga Rowing Association's Regattas scheduled for April 25th & 26th, May 2nd & 3rd, and May 9th & 10th. Supervisor Thomas Wood reviewed the measures taken to ensure the public's safety at the Saratoga Rowing Association's Regattas. Proof of notice in the *Saratogian* on April 2nd having been provided, Supervisor Thomas Wood opened the public hearing on the Mass Gathering Permits for April 25th & 26th, May 2nd & 3rd, and May 9th & 10th at 7:03 pm.

QSFD Chief Don Ormsby spoke **regarding** the regattas. He spoke on the blocking of Emergency Exits for the Emergency Equipment during the regattas. He asked that the Regatta Rules address it along with Saratoga Rowing Association's Operational Plan.

Sherry Doubleday asked if the boat washing station will interfere with emergency vehicles.

Supervisor Thomas Wood stated that he will forward both concerns.

Tax Collector's report: Tax Collector Jim Gorham reported that he has collected \$2,891,914.84 through April 6, 2015, on 2,784 parcels which is 92.9% of the bills. There were 212 bills unpaid for a total of \$599,531.45. On April 7th, the books were turned over to the Saratoga County Treasurer.

Assessor's report: Victoria Hayner submitted the following April 2015 report: March was a busy month in the Assessor's Office. We spent the month evaluating our Assessment roll. The various tasks required for update were adding exemptions, reviewing building permits and making sure valuation on completed as well as partially completed projects is updated as best possible. - Old town hall sale \$115,000 received and put into Building Reserve. Supervisor Thomas Wood noted that the partnership is working on funding for the design and construction plans that should be completed before fall. Construction is planned to begin in the Spring of 2016. Assemblywoman Carrie Woerner is proposing legislation that would allow the Historic Hudson-Hoosic Partnership to own the property.

Tenant Updates:

Supervisor Thomas Wood reported that **Adirondack Advocacy** is expanding into Day Care Services and would like to move into the old Tetra Tech space on the first floor. A fire door will be installed at their expense.

He added that **Adirondack Grazers** wants to lease the old Marvin space on the first floor. Resolutions will be introduces later in this meeting. Supervisor Thomas Wood added that Roohan Realty has a local business, **CAKE**, that is looking for about 600 sq.ft. for a cake baking business. He explained that she is looking at Suite 203, Room 3E. It would need water for sinks, gas stoves with vents, and the carpet removed. The board was concerned about odors. They felt the better fit for the space would be a business office.

Supervisor Thomas Wood reported that **Dr. Thomas Rosano** has shown interest in Suite 203, Room 2E, once Adirondack Advocacy moves downstairs. He is getting some new equipment and the space would need to be upgraded and wired for 220 v., with water, gas, and drains added at his expense. Supervisor Thomas Wood expressed the need for language in the lease to make it Dr. Rosano's responsibility to return it to its vanilla box state should he move out and to pay an additional monthly amount for the electric usage of the machine. Attorney Bill Reynolds suggested that we get estimates for the upgrades and that Dr. Rosano pay up front for the improvements. Supervisor Thomas Wood stated he will present Dr. Rosano with these requirements.

Public comments on agenda items: No one addressed the board.

Committee reports: **Landfill:** No report.

Insurance: No report.

Youth: Councilman Michael McLoughlin reported on the upcoming Swim Program that will be at the Christ the King Spiritual Life Center, Town of Easton, again this year. The program will run from July 6th through August 6th, 2015. He added that flyers will be given to the students at SCS in May.

Senior Citizens: The Old Saratoga Seniors met on March 18th with 41 members attending. Six new members have joined. Victoria Young & Chris Tucker brought the 5th & 6th Grade band to play for the group. A trip to Turning Stone is planned for May 25th. They met again on April 1st for a casserole luncheon. A trip is planned to Mystic, CT in September and to a Christmas Show in Troy in November.

The Quaker Springs Sunshiners met today for Chicken & Biscuits.

Park Committee: Work is ongoing to ready Schuyler Park for opening.

Office of Emergency Management: Sherry Doubleday reported that a meeting was held on March 30th to discuss the Emergency Management Exercise in greater detail. There is a final meeting tomorrow night to hopefully conclude the planning phase and participate in the actual drill.

Supervisor Thomas Wood and I will review the Town Emergency Plan in the next couple of weeks. Tom Rinaldi from Stillwater's OEM gave us their updated plan copy of 2013. Wording needs to be changed. I will get Supervisor Thomas Wood a copy to review.

Supervisor Thomas Wood reviewed the meeting he, Maggie Chiperno, Dan McCabe, Dick Behrens and I attended at the Saratoga County Training Center regarding a safety plan for dam breaches.

The OEM has a new Chromebook as of tonight. Now all materials can be put on it instead of my personal Chromebook and PC.

- Efficiency Plan Supervisor Thomas Wood explained that there is a June 1 deadline for submittal of cost savings from sharing services with other municipalities. The total savings needed to identify is \$9,205 for 2014 which could be proportioned between the town, GSES and fire protection. The benefit is to all taxpayers in the town if the \$9,205 savings is realized because they would qualify for a rebate of the increase in taxes in 2014. Supervisor Thomas Wood gave a couple of areas where the town might show savings. One savings was when we went to NYMIR for insurance. Another area to look at would be to share a Historian with the Village of Schuylerville. Board

members are urged to suggest areas where savings could be realized and Supervisor Thomas Wood will speak with GSES and Mayor John Sherman.

Senator Kathy Marchione- Veteran Nomination Submission. Supervisor Thomas Wood and the board discussed a couple of veterans and Supervisor Thomas Wood will call Senator Kathy Marchione's office with their nominee.
