Town of Saratoga Emergency Shelter Information Shelter Locations

In the event of an emergency the primary shelter for the *Town of Saratoga* will be at the *new Town Hall Building* located at 12 Spring Street Schuylerville. The building is at the intersection of State Routes 4, 29, and 32. Enter the building through the doors adjacent the rear of the parking lot, and follow the signs to the shelter.

Secondary shelters will be used if the need arises. They will be located at the David Nevins Fire Station Pine Street, Victory Mills,

the Quaker Springs Fire Station Blodgett Road, Quaker Springs and the Schuylerville Central School Spring Street, Schuylerville. *The severity and duration of the event will determine when the shelters*

are opened, and for how long they remain in operation.

Bring your own pillow, books to read, and perhaps your child's favorite stuffed animal. Bring any important papers you might need identification, passport, prescriptions, insurance policies etc. and any medications you may need. A change of clothes and any personal care items that you may require are always a good idea.

What to expect

Shelters can best be described as organized chaos, so be prepared to have little privacy and a very small area in which to function. The meals will be basic but wholesome. If you have any dietary restrictions, please bring these items with you. Special need items may be in short supply. *All will be required to sign in and out of the shelter, and a CURFEW* will be strictly enforced.

How to help

It would greatly help us to help you if we know in advance if you have any medical conditions or mobility issues that may require special attention. RU OK forms are available at the *Town Hall Emergency Preparedness Office* (2nd floor) to fill out for your special needs, or you can call **695-3644 X325** and have one mailed to your home. *Ourstine 222*

Assessor's Office News

Now is the time for all property owners to look over their information and file for any exemptions they may be qualified to receive. If you will be <u>65 in the</u> <u>year 2014</u>, you may be eligible to apply for the Senior Star Exemption if your income is under the maximum limit of \$81,900. But, you must file before March 1, 2014.

Many exemptions require renewal applications. These applications are color-coded this year and have been mailed. Please take time now to fill these out and turn them in to the Assessor's office. The deadline for renewal applications is March 1, 2014.

Other exemptions available within the town include Veterans exemptions and Agricultural exemptions. The Town recently approved the Cold War Veteran's Exemption; so if you have not qualified for a Veteran's Exemption because of dates, check with our office to see if you qualify for this new exemption. Certain criteria must be met to qualify for these exemptions. Please contact our office to determine if you might be eligible. All exemptions must be filed by March 1, 2014.

Reminder: The Assessor's Office is open Monday – Thursday from 9:00 AM until 1:00 PM throughout the month of February. We are located at the new Town Hall on 12 Spring Street, on the second floor. Please stop in and visit us – we'll be happy to answer your questions and help you apply for any exemptions you may be entitled to receive.
