Supervisor Thomas Wood opened the meeting with the Pledge of Allegiance at 7:00 p.m.

Approval of Minutes: A motion was made by Councilman Michael McLoughlin and seconded by Councilman Charles Hanehan to accept the minutes of the May 11th regular meeting as written.

Town Clerk's report for May 2015: Fees paid to the NYS Dept. of Agriculture and Markets for the Animal Population Control Program \$71.00. Fees paid to New York D.E.C. for hunting and fishing licenses \$283.44. Fees paid to the New York State Health Department for Marriage licenses \$45.00. The Board of Assessment Review met on May 26th and 21 town residents attended to grieve their assessments. There were also 6 mail in grievances, presented for review by the Board. The current Board of Assessment Review is a great team and they seem to work well together.

After receiving the decisions by the Grievance Board, we will input that data for the assessment roll. The Final Roll for 2015 will be available July 1st. Our update project is complete and we continue to assess at 100% of full market value.

The 2016 Roll will be created after the decisions are received from the Board of Assessment review and sales will begin to be entered and verified once again.

The Assessor's Office will be open from June 1 – November 1st on Tuesday and Wednesday from 9:00 AM until 1:00 PM. The Assessor will be in the office those days and we will not use a clerk for that period of time.

- **❖** Dormitory Authority of the State of New York (DASNY) has approved the Salt Shed Grant for \$100,000 through the State and Municipal Facilities Program "SAM". Highway Superintendent Don Ormsby will meet with representatives from the villages to discuss the plans and details of the shared services salt shed that will be built at the town highway garage site.

Public comments on agenda items:

Village of Schuylerville Trustee Dan Carpenter addressed the board with some concerns regarding the loading of the salt at the new salt shed. It was suggested by Attorney Bill Reynolds that a shared services agreement specific to the salt shed should be drafted that could provide details for its use and help alleviate concerns. Highway Superintendent Don Ormsby will meet with village representatives.

Youth: Councilman Michael McLoughlin stated that the town has contracted with the Christ the King Spiritual Life Center, Town of Easton, to run the swim program. WHEREAS, Lakes to Locks Passage, The Great Northeast Journey All-American Road scenic byway links the towns, villages, hamlets and cities along the interconnected waterway of Lake Champlain, Lake George, Champlain Canal and Hudson River; and

WHEREAS, the waters of Lake Champlain, Lake George, the Champlain Canal and Hudson River provide a beautiful backdrop to the scenic, recreational and natural resources along the corridor; and

WHEREAS, the cultural and economic history of the Town of Saratoga and City of Saratoga Springs should be showcased to travelers along Lakes to Locks Passage in Saratoga County; and

WHEREAS, The Town of Saratoga recognizes that tourism is an important industry to the County and believes that the designated route for Lakes to Locks Passage should direct the traveler through the Town of Saratoga and City of Saratoga Springs to increase visitor's desire to stop and visit; and

WHEREAS, the overall economies of the communities along the Lakes to Locks Passage will benefit from the boost in tourism that would result from the travel route with a "Saratoga Spur;" and

NOW, THEREFORE BE IT RESOLVED, that the Town of Saratoga encourages the State of New York Department of Transportation to modify the designation of Lakes to Locks Passage State Scenic Byway to add the "Saratoga Spur." The "spur" will extend from the Byway's intersection of US RT 4 and NYS RT 29 in the Village of Schuylerville, west along NYS RT 29 to the intersection with US RT 9 in downtown Saratoga Springs; and
